- Call the Meeting to Order and Proof of Notice: The meeting was called to order at 6:48pm. Proof of notice was provided in accordance with FL ST 720 and association's governing documents.
- 2. Determination of a Quorum: A quorum was established with the following Board members present; Kelly Bruno, Igor Gruendl, Suzanne Southerland, Brian Glassmoyer, Marti Tribolet, Ryan Reid, and Brandy Sheldon.
- 3. Approval of previous minutes (August 23, 2022): **MOTION** made by Igor, seconded by Brian to approve as presented. MOTION passed unanimously.
- 4. Presidents Report:
 - a. Hurricane clean up is underway. Tree and landscaping crew will be here all week.
