- 1. Call the Meeting to Order: The meeting was called to order at 6:47pm.
- 2. Proof of Notice: Proof of notice was provided in accordance with FL ST 720 and the association's governing documents.
- 3. Determination of a quorum: A quorum was established with the following board members present; Jim Deering, Brian Glassmoyer, Jay Brady, Kelly Bruno and Steve Lowe.
- 4. Approval of previous minutes 11/19/2024 **MOTION** made by Brian, seconded by Joyce to approve as presented. MOTION passed unanimously.
- 5. President's Report: Manager's Summary Report
  - a. Main lake fountain repair under way. Cable snapped, not under warranty. Cost estimated to be less than \$1,000.
  - b. Shell path repairs underway. Roots removed, weeds removed, crushed shell to be added.
  - c. Clubhouse pool resurfacing will begin this week (Thursday 1/30/25). Delay due to county permitting and weather.
  - d. Street drains quotes to be reviewed.
  - e. Community Drainage Review underway ZNS, Bryan Zoller.
